Mission Interpretation & Stewardship Committee

As we prepare to embrace a new year, we need to reflect on the positives and negatives of the previous one. 2018 was a bit of a struggle financially for our church. Where we had achieved a position of financial security by the end of 2017, that security was mostly eroded by the end of 2018. While we don't have the end of the year totals available at the time of this writing, it is pretty clear that we will fall short of where we need to be. Our First Fruits collection was also significantly below the expected totals however as we have done in other years the Session voted to make up the shortage from the General Fund. We did lower our pledge to Presbytery for 2019 to hopefully prevent this from happening again.

In the past, we have tried to encourage increased giving by asking everyone to prayerfully consider what they can give and also to remind everyone when we are in dire financial conditions. This "sky is falling" approach may not be the most successful available. This year, we are going to try to focus on the positives and encourage giving by stressing generosity as a theme. When we remember how generous God has been to us, we should want to reciprocate that generosity. And we hope to highlight the many good works that we accomplish through our giving. Obviously, there is a large commitment required just to provide a regular place of worship and a staff for that worship. But we want to go above and beyond that. With the help of everyone, we can achieve great things.

As part of every member's financial responsibility to the church, we collect the Per Capita for each member. This is the amount that we have to send to Presbytery for every member on our rolls. This year that amount is \$42.50 per person and should be given over and above your normal giving. Please mark either your check or your envelope "per capita".

In closing, I want to share with you a quote from J. Hudson Taylor. "God's work, done in God's way, will never lack for funds. Generosity is contagious. God never promised to meet our budget, only our needs."
