WEEKLY WORSHIP SERVICES FOR JANU-ARY


Over the course of our time of social distancing, a short meditation with Pastor Cliff has been uploaded to the Congruity Facebook page each Sunday morning.

ITEMS FROM SESSION/DEACONS

The Session met on December 21, 2020 and reports the following:

- The elevator was recently inspected.
- All employee contracts have been signed and placed on file.
- The date for ordination and installation of Elders and Deacons is set for January 17, 2021.
- The Annual Congregational Meeting will be held January 31, 2021. This meeting will be during worship. Please note there will not be a soup and sandwich luncheon afterwards due to COVID-19. If the Church is not meeting in person the Church Manual will be set aside for this year and the meeting will be held the first Sunday we return to in person Worship.
- Christmas ornament kits were delivered to all Sunday School children.
- The session elected John Blank as Treasurer for 2021.
- The Session approved the purchase of Quickbooks software to be used by the treasurer.
- If the 2020 First Fruits pledge is not met, the session voted to instruct the treasurer to make up the difference by using money from the General Fund.

MISSION INTERPRETATION + STEWARDSHIP BY TIM D'AURORA

I have often said I really don't ever want to wish my life away. We never know what the future will bring, but 2020 was a year that I think everyone will be glad to see in the rear view mirror. As a congregation, we have probably been more fortunate than many others. We have not had an abundance of illnesses from the Corona virus, and we have weathered the financial storm pretty well. Obviously, that is due to everyone's tremendous response throughout the year. Even though we have had to cancel a significant portion of the year's in-person worship, you have continued to support the church. At the end of November, our year to date balance was -\$6,123.63. When you add in the payroll protection loan that will be forgiven, we are actually sitting on a positive balance of \$9,376.77. Our First Fruits donations have been down a little, and at the end of November, we were sitting on a shortfall of \$960. But as of December 25, that has been reduced to \$415.00. I'm hopeful that by the end of the year, that number will be even lower. The Session has voted to make up any remaining shortfall from the General Fund. Hopefully, this will be a small amount.

Looking forward to 2021, we are excited about our opportunities moving forward. We certainly missed the working fellowship and the funds generated by the spaghetti dinners. We would like to return to having 2 of them during 2021. We did have success with a hoagie sale, and are considering adding a third one this year. These are chances for you to make a positive difference in the financial well-being of our church without having to stretch your own finances to do it. The more involvement from everyone, the more successful we will be.

One area we did improve on in 2020 over previous years was our Per Capita response. This year we want to do even better. As most of you know, Per Capita is the per person amount we pay to Presbytery to cover their costs as well as the costs for Synod and General Assembly. Also, a large portion goes to support Mission. This year, the Per Capita amount is again \$42.50 per person, not per family. We ask that each member donate that amount above and beyond their regular giving and note it as such on whatever form of payment you make.

An area of concern is the continuing expense of the elevator. While the elevator has been a huge blessing for many of our members (and for Tim having to move things to the 3rd floor), it is also 12 years old and seems to continue to have expensive repairs. Anything extra that you can spare can be donated to the building maintenance fund acknowledging the elevator.

As a closing thought, it looks like we may be receiving another round of stimulus checks. While many people desperately need whatever help they can get, there are others that have continued to work or have cut expenses and look at this money as somewhat of a luxury. Why not give part of that luxury to the church.

Another way to help is to think of the church when you do your estate planning. You are not limited to donating cash to the church. Stocks, bonds, real estate, etc. are perfectly acceptable forms of giving. And doing so may have a definite tax advantage. Check with your accountant for more information.

For 2021, get more involved! Together, we can make this coming year a positive rebound to the disappointment that 2020 was for so many.
